PURPOSE OF MEETING: Water Line Repair

Issue: Service line from house is leaking.

Background: In 2013, water service failed and GLASWA replaced it with K copper. Supervisor Englerth noted that K copper is supposed to last 100 years. The replacement of five years ago has failed. Englerth noted that time was of the essence. Englerth commented that possibly there is an electrolysis problem with the K copper that should have lasted. Englerth commented that PEX (cross-linked polyethylene) should be put in and plastic lasts 80 years.

It was noted that The Swarthouts came to Larry Knowles, of GLASWA for relief. L. Knowles referred them to the Township Board. Discussion of the Board occurred, followed by discussion with the homeowners, Trevor & Madison Swarthout.

Motion Jansma with support from VandenBerg to have GLASWA oversee and make the repair at 12860 Goldenrod, Wayland, MI as Englerth and Knowles discussed (running PEX). Motion by Englerth with support by VandenBerg that financial burden of line repair is not born on the homeowners, The Swarthouts, of 12860 Goldenrod, Wayland, MI and cost will be between township board and GLASWA which is to be negotiated at a later date.
