FIRE SERVICES COMMITTEE: Trustee, Roger Rottschafer

- The fire station is up to 15 volunteers.
- Wayland unanimously approved the new contract Rottschafer will distribute a copy for everyone to go through and a special meeting will have to be held.
- Possible Mutual aid agreement with Thornapple Twp. was discussed.
- Thornapple Twp. voted to allow the contract to end March 31, 2016. Yankee Springs will be on its own as of April 1, 2016.
- Dated March 15, 2016 action taken from Thornapple Township: Thornapple agrees to terminate the contractual agreement and vacate the Yankee Springs Fire Station as of April 1, 2016- pending YS's Board of Approval. All property will be returned to the prospective townships. (Including final payment of \$14,022 from Yankee Springs to TTES.)
