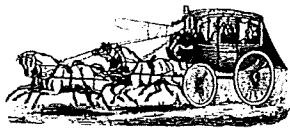

- Is advertised to the public and does not occur regularly on the site
- Impacts use of County/Township streets and right-of-ways
- Uses Township facilities or property

Examples of Special Events include:

- Road Race, Bicycle Race or Walk - Submit Route
- Parade - Submit Route
- Festival, Carnival or Market
- Concert
- Automobile or Boat Show

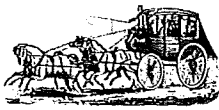

RELEASE & INDEMNITY AGREEMENT

This contractual indemnity provision does not abrogate common law or statutory liability and indemnification to the Township, but is in addition to such common law or statutory provisions.
