

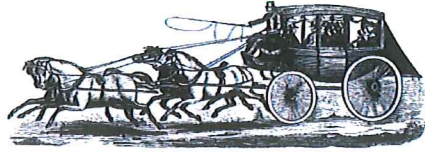

YANKEE SPRINGS TOWNSHIP ELECTION COMMISSION

*Resolution # 02-28-2023*

WHEREAS, Wayland Union School District will hold a Special Election on May 2, 2023;

WHEREAS, due to the township hall being unusable as a voting place for precinct 1 due to the hall/office expansion/renovation project - Precinct 1 will be consolidated with precinct 2.

NOW, THEREFORE, BE IT RESOLVED, that for the May 2, 2023 Special Election for the Wayland Union School District Bond Proposal only, the voters will be re-assigned as follows:

- The 193 voters in Yankee Springs, Precinct 1, Wayland Union School District will vote at the Yankee Springs Township Fire Station, 1425 S Payne Lake Rd, Wayland MI – Barry County (MCL 168.659 as amended under PA 296 of 2004)

NOW, THEREFORE, BE IT RESOLVED, that the Yankee Springs Township – Barry County Election Commission directs the Clerk of Yankee Springs Township to notify those voters 60 days prior (completed on March 3, 2023) of the election date by first-class mail of the change in polling location and address of the Yankee Springs Township Fire Station for the May 2, 2023 Special Election Wayland Union School District Bond Proposal. And to post a written notice at Precinct 1 location Yankee Springs Township office and at the consolidated precinct 1 and precinct 2, location stating the location of the consolidated Special Election at the Yankee Springs Township Fire Station.
