PUBLIC COMMENT

Rob Heethuis, Lisa Lane commented, referring back to the well testing result, "... I can't question it, I just didn't hear enough about it. I heard Mark say one thing; I heard Larry saying something else-that he was holding a Fleis & VandenBrink report, didn't quite sound like what you were talking about, Mark. Larry requested Fleis & VandenBrink be here in July, which I think is a really good idea. They're the ones that wrote the report, let's find out what they did. I heard that we've already ran out of budget money so to go beyond, we have to get more budget money, which means we are going to spend more money. Why didn't we get it right the first time? Mark, I'm not exactly sure what you tested for your well, but if you tested a well at your property, and you're beyond budget, maybe, you should bite the bullet and replenish that money, pay it back to the township and let the testing take place that should have been taking place. I'll look forward to the July meeting."

Dave VanHouten, Rock Dr., commented that he was "kind of blown away here. Wells were tested, March 11. The results weren't shared. Bill was submitted. It drags out. We still don't know the results of that testing...(A. Jansma commented, at this time, that the board members had the results). I'm glad you have it -(replied VanHouten to A. Jansma.) (Jansma then commented that the whole board had it.) It sounded like it really was not shared. I think it's just not right, Mark, that you had a well on your property- your well-tested. It's just not right. It doesn't look good. I don't think it's proper. I think it should be refunded to Yankee Springs. And I can't understand why when test wells were put in that dump there, monitoring wells, why we've never monitored those wells? It just makes sense, from the information I have, to test those wells.

BOARD COMMENTS

- **S. VandenBerg,** commented in response to the Public Comments, "I do understand and I want to be very clear that I do understand. I just want to make that point."
- **J. Lippert** mentioned adding to the agenda of July that the PC spot is open and there are applications received for it.

Lippert also mentioned COVID, and commented that more than 10 people will be allowed at July 9th meeting. Lippert noted that people may still have to sit six feet apart, may still have to wear a mask. "Wash your hands as good people do," added Lippert.

M. Englerth commented, "For 28 years, my well was abandoned in my house. It was underneath the stairway. It was never used. I had to give the electric motor service shop a hundred bucks to get the motor going. I spent a day and a half priming it so we could test the quality of the water. There was no benefit to the Englerth household, whatsoever. Zero. My expenditures already was a day and a half. What's a day and a half of your time worth? So we've got a couple guys running for office that would like to throw stones that really don't know what they're talking about. Period.

Stop over (at) the house. I'll be glad to show you. Okay, take a day and a half out of your life to make a better community, a better spot, and then throw stones at somebody. Thank you very much. Meeting adjourned." (At 7:55 p.m.)

VanHouten commented, "I will worry about the election later. But what I can say is it was totally improper for you to do that."

Englerth commented, "Meeting's over."

VandenBerg commented, "Point of Order."

VanHouten commented, "I'm speaking..."

VandenBerg commented again, "Point of order."

VanHouten commented, "You can listen or not listen. That's the way I see it."

VandenBerg commented again, "Point of order."

VanHouten commented, "I can express my views."

Englerth added, "Like I said, I invited you over to the house."
