M. Englerth commented on attending a Supervisor Seminar in Frankenmuth recently.

An Emergency Services Appreciation Day is being planned for sometime around Sept. 11th. Contact M. Englerth to help with this. An individual in the community has recently passed away and his family will be involved.

Robbins Cemetery – M. Englerth mentioned the possibility of adding a fence. Discussion took place. Several trees and stumps have been taken out (approx. 50 trees). Other work has been completed as well. A bill has not been received from B & R or Ritchie's Tree Service.

ZONING ADMINISTRATOR REPORT: Larry Knowles, Zoning Administrator – (Written report submitted.)

The **Planning Commission** held a hearing for an SEU for an outbuilding on Sandstone (July 20, 2017).

The PC will hold a hearing for an SEU for an outbuilding on a vacant property without a principal residence – (August 17, 2017).

GLASWA Report L. Knowles, Director

MOTION FOR LEGAL COUNSEL regarding BARRY CTY. ZONING

Discussion:

L. Knowles said that he has made the contacts and hasn't received any information from anyone. L. Knowles commented that he, personally, as a citizen on Gun Lake, has asked for a hearing with the Barry County ZBA. L. Knowles' inquiry is about the 20 slips already in place. Items discussed were:

- -Lack of any communication on the part of Barry County Zoning regarding public procedures and permitting process of the marina project
- -Barry County Zoning's neglect of the YS Resolution
- -FOIA authorization
- -75% of Gun Lake is in Yankee Springs Township
- -Concern of marinas possibly coming in on other lakes (such as Payne, Barlow)
- -A request for a Special meeting with the YS attorney
- -Authority to authorize legal counsel
- -Timeline for the attorney's availability was discussed since project is scheduled for Monday, August 14
- -Legal expense and township liability
- -A possible meeting with Vivian Conner, Greg Purcell and Michael Brown
- -Maintaining a positive relationship with Barry County Zoning
- -Saturday, August 12, at 9:30 a.m. will be an annual meeting of the GLPA, at the Gun Lake Chapel. Members of the GLPA are invited to come. The marina expansion is not on the agenda at this time. GLPA is waiting on the DEQ.
- -The DEQ references local zoning approval and other agency requirements in its permit application.
- -Can the township be sued for asking Barry County to enforce their (Barry County's) zoning laws? YS Twp. isn't the one issuing the permit.
- -At the previous YS Board (Regular) Meeting, L. Spoor commented that Mr. McManus (of Barry County Zoning) said that all Spoor needed was a soil erosion curtain, and materials are ready to start project.
- -G. Purcell offered to sit down with Vivian Conner, M. Brown, J. McManus and L. Knowles to ask about their (Barry County's) public procedure (step by step) of what Spoor should be applying for to be issued a permit.

-M. Englerth, Supervisor, commented on turning the <u>discussion into a public forum</u> and reiterated maintaining positive relations with Barry County Zoning for the future, and not having the attorney involved yet. Englerth commented on having good relationships with McManus' office in the past. Englerth commented that he repeated what he was told by McManus, "Until there is a resolution, a request put in front of him, then he cannot comment. It would be premature. It would show bias going into it. Englerth commented on talking to Michael Brown first.

- **R. Rottschafer** redirected the discussion to the issue being with the 20 slips that are already in.
- **G. Purcell** commented that public information should be shared regarding the public process and criteria of the County.

Englerth commented on struggling as a board as to what is the best vehicle to find out the information. Englerth commented that the board wants an understanding. Englerth commented again that there will be a need for positive relationships (with Barry County Zoning). Englerth commented "I know when you sic an attorney on me, and start coming after me, probably the chances of us holding hands and singing "Kum Ba Yah" is not as good." Englerth suggested having Vivian Conner, Greg Purcell and Michael Brown sit down and maybe have M. Brown address it. (M. Brown is J. McManus' boss).

- **-L. Knowles** commented that M. Brown has been copied on everything. It was noted that Michael Brown's boss is the Barry County Board of Commissioners. L. Knowles commented that he has talked to three Board Commissioners and hasn't gotten anywhere.
- -Vivian Conner will take the YS Twp. Resolution back to the Board of Commissioners as a complaint from YS Twp.
- -R. Rottschafer commented on asking C. Kaufman to speak to J. McManus as a friend, and cohort in zoning and teaching, which wasn't an action that Rottschafer felt needed board approval.
- -A comment was heard from L. Spoor that he and his attorney are reviewing possible legal action against GLPA and Yankee Springs.
- **-J. Lippert** commented L. Spoor's FOIA request was ready at 3:00 p.m. on Friday, August 4th as required. L. Spoor called the Township office would not be able to pick up the FOIA's documents due to an emergency. Nothing has been heard from Spoor since regarding his FOIA request.
- -S. VandenBerg recommended having a meeting with the township attorney.

The Board agreed to set up a meeting with C. Kaufman. J. Lippert will contact the attorney to schedule a meeting.

- **F. Fiala** inquired as to what the DEQ permit application says regarding Barry County Zoning.
- **L. Knowles** said the DEQ permit app says, "This does not relieve your responsibility to meet the other agencies' ordinances."

Fiala voiced his concern about previous projects starting and being difficult to stop once started. Page 7 of 7 Fiala added "Action needs to be done quickly. It certainly needs to follow all the procedures and doing all the right things, talking to all the right people." Field commented on being a little 8.10.17 doing all the right things, talking to all the right people." Fiala commented on being a little disappointed in not getting any response for legitimate questions regarding procedures followedespecially with the 20 units that have already gone in.

FINAL MINUTES

Englerth commented on being on the same page as a team. "WE will make those decisions" commented Englerth. Englerth again brought up the need for good relationships with Barry County Zoning with future work on the Gun Lake Overlay District, and old commercial zoned areas in Yankee Springs that need to be looked at.

Englerth asked L. Knowles if he was happy if the Board takes one step with Greg and Vivian speaking with Michael Brown.

Knowles commented he's not comfortable if works start on Monday. "We are not prepared for construction on Monday," stated Knowles. Knowles voiced being beyond angry with the issue. Knowles commented that he has put a lot of energy into it and has begged Barry County and has not gotten anywhere.

Resolution will go to Vivian Conner to present to the Board of Commissioners.

Motion by Rottschafer with support from Jansma to rescind previous motion on the floor regarding authorization of C. Kaufman to attend Barry County ZBA meeting with L. **Knowles.** (Vote was not taken on motion to rescind).
