## CLOSED SESSION Minutes: (of Dec. 14, 2017 and Dec. 20, 2017.

Closed Session Minutes were Reviewed by 3 board members: Mike Boysen, Alice Jansma, and Mark Englerth. (Abstained and moving to audience were: J. Lippert and S. VandenBerg. J. Lippert and S. VandenBerg were not in the Closed Sessions of Dec. 14 and Dec. 20,2017).

Motion by Englerth with support from Boysen to approve closed session minutes of Dec. 14 and Dec. 20, 2017 as presented. Roll Call: Jansma: Yes, Boysen: Yes, Englerth: Yes. Yes: 3, No: 0. MOTION CARRIED.

## PUBLIC COMMENT: (Limit 3 minutes)

Julie Fox commented that she requested (called and emailed Janice) to be on the agenda because she PUBLIC wants to have more than three (3) minutes (Public Comment has a limit of 3 minutes).

Jan Lippert commented, "She asked to be on the agenda, and that's where I put her."

Julie Fox, of Hastings Pt. Rd, commented that she would need more than three minutes. J. Fox also commented, "I would like to address conduct of Jan Lippert towards me personally and my small (local?) business. As a little bit of background, I attended my first meeting in October during Public Comment I had intended to update them on my small businesses. Where I came from, where I am right now, and where I am going. I ended speaking up because of the tone, in my opinion, and inappropriate comments made by a township official toward another board member. I subsequently received a complaint concerning my business just days after I spoke up at the October township meeting. The timing of me speaking as a citizen and the complaint, left me to wonder could the complaint be related to me voicing my opinion at a township meeting? On October 12, I spoke up at the township meeting. On Oct. 17th, a complaint was filed against my business. On or about Oct. 24th, I visited Ms. Lippert at the township office asking for a copy of the complaint and was told that it was their policy not to provide that information. I was told she did not know who filed the complaint. I specifically asked her if she knew and she said 'No. She did not'. I explained that I did indeed have every right to that information. So I then had to file a FOIA (Freedom Of Information Act) application. The municipality then has five days to respond to a FOIA. On Nov. 13th, after missing the five day allowed response time, I followed up multiple times, I then visited Ms. Lippert in her office asking why I had not received the information I requested. We had an eight (8) minute long conversation concerning the complaint. On October 13th (confirmed on audio - date given was Oct. 13), I received a response basically advising me that Ms. Lippert did not know what I was requesting when I filed the FOIA act. So I filed it. It was pretty clear. I had an eight minute long

conversation with her about it, and her response to me was late upon that she didn't know what really FINAL MINUTES I was wanting. On Nov. 20th, I received a response that Robert Lippert and Janice Lippert had filed the complaint against my business. So in, not only did she violate the FOIA by not allowing me to get it, responding late, but in official capacity she told me she had no idea who had filed that, when indeed she did, because it was her. On November 27th, believing the complaint was filed in retaliation for my comments at the meeting and believing I would find a pattern of our clerk retaliating against those who speak up against her, I filed a FOIA asking for copies of all complaints filed in 2016 and 2017 by Bob or Robert Lippert and Jan or Janice Lippert. I was asked for an extension which I granted but made clear I needed the information a few days before the meeting and that was the last meeting (December 14, 2017). I was sent a written notice from Janice that I would receive the information on the 15<sup>th</sup> which was the day after the meeting. I had a stern conversation with her and she came to my place of business with the information. As a side note, after a written request to be on the December agenda, I was not listed. So, she wants to give me the information I requested in plenty of time, after the meeting, when I let her know that there would be consequences, and that I wasn't playing these games. She brought it to my place of business, but then when I came here, I wasn't on the agenda which I put in writing requesting that I would be. So, as stated at the last meeting, this is kind of where we were in the whole scenario. When I finally did get the information from Janice, there were three people that she listed that she had filed complaints against. And sure enough, there's a pattern of retaliation. There was a complaint against Mark Englerth, Shane VandenBerg, and Julie Fox. I live on a private road. There's no reason to be there, and I've got Mr. Lippert driving past my house. I don't know. Looking for a violation? I don't know what. But it's very strange. So, a logical assumption would be that these complaints were made in retaliation for expressed views Ms. Lippert does not share. So, just when you think it couldn't get any worse, on December 21st, I visited the township office when I asked Janice Lippert if she or her husband had filed a complaint in 2016 or 2017 against Dave Neeson. Because what I asked for was all complaints, so anybody she filed a complaint against should have been in that FOIA. Again, a citizen who has voiced opinions against her, so Dave Neeson has voiced opinions that have differed from Ms. Lippert. Her comment was, 'I have no recollection of that.' I told her that Mr. Neeson was aware of the complaint, but that Larry Knowles had not yet contacted him on it. This was before Larry had resigned. I stated that both Larry and his assistant Mike would know of the complaint. She had then stated she had no idea of what happened to the complaint because it was handed over to Larry. She then stated that maybe it was just verbal or really not a complaint at all. Maybe it was just conversation. I then pointed out that she had just stated that she had no recollection of the complaint. But now she has knowledge that it was passed off to Larry. So indeed, she did have knowledge of the complaint because she was the complainant. She stated that she had misspoke, had no idea of the complaint and would look through her files but that our conversation was over. I followed up with Larry Knowles and he clearly recalls the complaint made by Janice Lippert against Dave Neeson. Again, this should have been in the FOIA that I filed and it wasn't. You don't forget things like that. I'm sorry. Larry confirmed that the complaint was in writing – not verbal. But upon him going through the files for the complaint, he could not locate it. If I filed a complaint against somebody, I'd remember it. She knew she filed also a complaint against Dave Neeson, and gosh only knows who else she's filed complaints against that are no longer in a file. And, if the file is gone there's only one person would benefit from it, and that's Janice Lippert. On December 22, I received Janice Lippert's response to my FOIA request and it said I hereby certify that the township does not have any such documentation, this is me requesting the information about Dave Neeson, does not have any such document in its possession. Accordingly, your FOIA request is respectfully declined. She had an opportunity here, to say 'Look though, upon thinking about this, and upon talking to Larry about it, I do recognize that I did do it. So, in total transparency I'm going to tell you that (I) didn't find a file,

but yes, indeed, I did.' But she didn't. There's a thing called Malfeasance in Office. It is the commission of an unlawful act done in an official capacity which affects the performance of official duties. It protects citizens from public officials who retaliate against a citizen for doing what I did. Speaking up in a meeting. Or, when they use their office to hide or conceal something that is protected under the Freedom Of Information Act. All these things have happened in my short experience with her multiple times. And the last thing I want to say before I finish is, you know our clerk is supposed to act in our best interest. We are starving in this community for nice businesses that help our community look great and things that we can be proud of. I've invested over \$700,000 in doing just that. If we do everything that I have on the boards, my husband and I will have invested over \$1.5 million in our little strip here that we so sorely need. I employ 35 seasonal employees that would no longer have a job because my business was going under and sold off in pieces and parts. I have 12 year-round employees. I employ local plumbers, electricians and tradesmen. I didn't go outside to local areas. I didn't put anything out to bid. Anybody that had Yankee Springs something electric or plumbing or whatever behind their name, that's what I hired and you can ask them, and this is what I get? You've got to be kidding me. So, what is happening here is corruption. We can't do anything about corruption that happens in the State of Illinois, in the State of Michigan, you know, in Washington, but we sure as hell can do something about the corruption that is happening right here. And I for one, am not going to take it anymore. Janice Lippert, if you do not resign from your position, I'm going, with my attorney, to the Barry County Sheriff's Department and I will do anything within my power to make sure that you don't have this opportunity to keep our citizens from information that they rightfully deserve and use your office to cover up things that you do not want people to know. And that's your choice. I'm asking for your resignation.'

- **J. Lippert** stated that she had no comment to her. "I will contact the Attorney," stated Lippert.
- **M. Boysen** asked, "Is there anything short of this resignation that would appease you? Like a public apology? Is there anything we could do short of getting the sheriff involved and paying a lot of legal fees. My take on it is that Janice has been here a long time and has done a lot of good work, and we all make mistakes. It seems like there's a possibility for a compromise. Is there anything that you can think of that would allow that?"
- J. Fox commented "So, there isn't. And it's not because I'm out to get Janice. It's because I care about the greater good. I know I'm not the only person this has happened to. I'm the only one that's has had the time or maybe had the gumption, or whatever, to find out what my rights are and make sure that those are accommodated. You know she has been here for a long time. That might be part of the problem. Because people that are part of this township, that have been here forever, just think they can do whatever they want. And it is corruption. And I gave her so many chances to maybe dig herself out of the hole and it just keeps going even until tonight she knew that I asked to be on the agenda so I wouldn't be limited to three minutes but yet she still put me under the Public Comment. It just keeps going and going and going. And it's just so wrong. This isn't a misunderstanding or what did she call it, "I misspoke." It's not that. It's an arrogant attitude of entitlement that they can do whatever they want. You (pointing to someone on board). Not you. You (pointing to J. Lippert?) to me or anybody else and they're not going to pay any penalty for it. And no. It's done. You know, I had a grievance with Alice.

(Mark Englerth briefly interrupted, saying "Don't Julie." or "No. Julie.")

J. Fox continued, "And I had a grievance with Alice about how one particular thing was handled. And she has been nothing but wonderful. The complete opposite. We have a specific problem here. A cancer that needs to be removed."

Larry Knowles, Director of GLASWA – (written report in agenda packets) – commented regarding the sewer planning on a sizable construction project coming up. Knowles referred to the board signing a resolution (approx. a year ago) to enter into a contract to secure a bond. The sewer is at the point of securing a bond. The Board (GLASWA) has asked for a not to exceed amount of \$2.5 million. Contracts are being prepared for the township(s) to sign. L. Knowles requested to have the signing of the contract on the February Board of Trustee meeting agenda (2/8/18). Drawings are at the DEQ right now.

Knowles also requested Clerk Lippert to have the updated sewer ordinance relating to the new rates be placed on Municode.

Don DeVries of Fleis & VandenBrink commented that five years is up and a water reliability study of the system is due. D. DeVries commented on the procedure that takes place and that it will not be done in the winter. M. Englerth commented on having a workshop and a little bit of one-on-one time regarding the reliability study to understand the system and the history. Most likely it (project) will be done in the Spring.

**DRAIN COMMISSIONER, Jim Dull** commented on the start date of the dam construction and progress up to this point. J. Dull noted that M. Englerth was taken out as spokesperson of the Board. J. Dull feels this was a mistake. Dull typically goes to a Township Supervisor, not the Treasurer, Clerk or Trustee. J. Dull requested that Englerth be re-instated as the spokesperson. Dull commented that it would make his (Dull's) life easier (to work with Englerth).

Motion by S. VandenBerg with support from Boysen to have M. Englerth take his supervisor's duties over and tear up the resolution taking away the spokesperson role of the supervisor away. Boysen commented he'd like to second the motion and he wanted to go on record saying that when he read about "how that whole thing transpired (resolution to remove Englerth as spokesperson for the township), it was mystifying to me. We have a process, a democratic procees that works pretty well and it's called an election. And when you disagreed with what somebody is doing in an elected position, you change that with a ballot."
