**VandenBerg** thanked **M.** Englerth for all of his efforts, diligence and perseverance in putting up the memorial. Englerth commented that it was a community effort, and was due to the donations of others.

Englerth opened discussion up to the audience at this point:

- **R.** Heilman asked if they the flags could be put up. Heilman noted that the American flag would have to be the highest. Heilman also asked what other flags would have to go up.
- **D. Van Houten** agreed with R. Heilman on getting the flags up and agreed not to spend the money to put on the printing of the back of the monument.
- **M.** Haack also agreed with Van Houten, having just one side printed, because the monument couldn't be read at the higher speed on M-179.

**Englerth** mentioned if the landscaping goes in first, then it will have to be taken out for sprinklers to be put in.

COMMENT

**PUBLIC COMMENT**: (Limit 3 Minutes) For Verbatim Comments:

Full audio recording of this meeting which is to accompany the written minutes (for this meeting) has been downloaded to the township office computer system on 6/13/19 immediately following meeting,

Cathy Strickland, voiced her disappointment in the board tonight, regarding the failed motion to nominate Mike Boysen to the Planning Commission. She asked to take another vote. Citing Robert's Rules of Order, Strickland wanted to hear A. Jansma's and L. Knowles' reasons for their votes against Boysen.

Jansma commented that there was "more to it than that".

- M. Englerth noted it was "Public Comment not Public Discussion".
- G. Medendorp, of Vista Point, C. Strickland and S. VandenBerg all noted they wanted A. Jansma and L. Knowles to explain their votes.
- G. Medendorp commented "I agree with this woman (C. Strickland) totally". G. Medendorp voiced her disapproval of the negative votes toward Boysen as well.

An unidentified audience member said, "Well said."

On a different subject, Kristy Dombkowski, Assistant Scout Master, commented that if the township were looking for "man or boy power" on township projects – contact the Middleville Methodist Church.

Kevin Pitcher, Pine Meadows Drive, noted that he has been coming to meetings and has seen discord with the board, and "it is kind of unsettling." Pitcher commented on board positions as positions of responsibility, not power.

Matt Haack, representative of Pleasant Valley Condo Homeowners Association, in regards to the Robbins Cemetery -Haack noted that the property actually borders Water Lily and Chief Noonday. M. Haack heard "Golden Rod" mentioned and wanted to make the clarification. If changes are to be made, M. Haack asked that the board "please reach out and keep us in the loop." Haack noted that his HOA is looking at a project of 20 to 30 spruce trees and he will stay around after the meeting to possibly work together on the Robbins Cemetery.

## NEW/OLD BUSINESS/ BOARD COMMENT:

Discussion on clarification of direct and indirect fees.

VandenBerg commented that the (township) board can take care of it (clarification of direct and indirect fees). VandenBerg confirmed that A. Jansma was on the Water Advisory Board.

Englerth commented that at the next regular board meeting it will be part of the agenda.

VandenBerg commented that he wants information going out to every single person on the water system because records are gone, "we just don't have them. They're just gone!" VandenBerg commented that he was good with transparency.

Knowles commented that he wanted to set the meeting date for this item.

**Englerth** confirmed that it (a meeting regarding clarification of direct and indirect water fees) would be at the next regular board meeting, and a mailing will be done to people on the water system.

## Change of Subject occurred at this point:

**VandenBerg** asked L. Knowles and A. Jansma to be "very specific" on why M. Boysen was not voted to the PC position.

- **L. Knowles** commented that it was the first he had heard about it and he was told people were to be interviewed. Knowles commented that the interviews should have been and should be done. Knowles noted that the make up of the Planning Commission with representatives of non-lake owners and lake owners is a concern of his.
- A. Jansma commented that the office had never received application for M. Boysen to be on the Planning Commission. Jansma told of M. Englerth coming into the office noting that M. Boysen had filled out an application for the PC. After clarification with Boysen, two days ago, it was confirmed that Boysen had an application for the Board of Trustees filled out, previously. Jansma commented that the office had been accused of doing something with Boysen's PC application, and the office had not done anything with it.
- **M. Boysen** commented that A. Jansma was correct in what had taken place. Boysen commented that the application information was the same for the PC position. Boysen commented, "You know who I am."

**Knowles** asked for a point of order, to move forward.

S. VandenBerg commented "We are moving on. I'm hopeful that we have another vote."

At this time, Motion was made by VandenBerg "to kick it back and vote again" (on M. Boysen) (to Planning Commission). (Motion was not supported).

**VandenBerg** commented on needing a person on the PC, and the expense of going to the paper to re-advertise for more people (for the PC) "because two people on this board don't want him on" because of an application.

**Englerth** commented that his goal tonight was to move in a positive direction, and "we will relive GroundHog Day" again next month. Englerth noted that ZBA members were voted on. He commented that it (PC Nomination/vote?) was very disappointing and embarrassing.

**VandenBerg** asked if the Board was going to ask for more applications for PC members when they already had an applicant (M. Boysen), whom VandenBerg said would represent the community in a "reasonable fashion". "That is a problem for this township board. Let me tell you," added VandenBerg.

Bill Medendorp, of Vista Point, commented about not caring about being out of order and that he wanted to know something.

Knowles called for Point of Order.

Englerth commented, "Bill. Bill".

**Bill Medendorp** commented "....Close of meeting... they will know."

M. Boysen commented to M. Englerth, "Why don't you just interview me, right now."

**Knowles** called for Point of Order.

Jansma called for Point of Order.

**Englerth** commented to Knowles that he didn't need two interruptions. "Have you got it?"

Knowles commented, "Yes I've got it..... control this."

Englerth told Knowles, "Be quiet."

Knowles commented, "Then finish it."
