OFFICE/HALL RENOVATION UPDATE

BOARD ACTION ITEMS:

- Office/Hall Renovation update:
 - Fleis and Vandenbrink Engineering Inc. was notified by email on 10/15/2021 that the BOT had approved the large office and revised hall design at the 10/14/2021 board meeting.
 - Our IT provider, Ocean Inc. has been notified that the project was approved. They want to be involved in helping us to include what is needed for the present and future in the design.
 - Fleis and Vandenbrink and Ocean Inc. have been put in contact with each other to coordinate the IT part of the project.
 - Emails the weeks of 10/18/2021 and 10/25/2021 discussed the ceiling height in the new office and the project schedule with the goal being to be able to use the hall as much as possible in 2022 for elections and meetings.
 - o The office addition will be built while we work in the existing building, and then we will move into the addition while the existing office work is being done. The new zoning office will be used by the treasurer until the new treasurer's office is completed.
 - o IT provider will help with that transition to keep everything running.
 - o There will be at least a monthly meeting between the Township and Fleis and Vandenbrink to review the design and make sure we get what we want as efficiently as possible. The 1st meeting will be around 12/1/2021. The design work is expected to be complete in February 2022.
 - Agreement has been signed with Roger Swets to manage the financing paperwork.
