

WAYLAND FIRE DEPARTMENT

AUTOMATIC MUTUAL AID FROM TTES

This automatic mutual aid agreement is set-up with (TTES) fire department and Wayland Fire Department. This agreement is designed for response on **structure fires only,** in residential, commercial and industrial structures into Yankee Springs Township

Since this is a mutual aid agreement/response (TTES) fire department will be responsible for all the cost of their apparatus, manpower, insurance and injuries or any other cost that would occur during the call.

This agreement will remain effect unless either party provides a thirty (30) day written notice.

1st. Alarm Call (All Structure Fires)

TTES Fire Department is requested to respond with;

- Pumper with two to five firefighters 1 water tender with two firefighters,
 All firefighters responding with above apparatus must have full turnout gear with SCBA's.
 Exception: Water tender operators do not need SCBA, but must have full turnout gear with them.
- 2. Barry County Central Dispatch will request automatic mutual aid from TTES fire department. For mutual aid area to be covered see attached map.
- 3. It is the responsibility of the assisting fire department to upgrade another fire department into their service area for coverage while assisting Wayland Fire Department into Yankee Springs.
- 4. Automatic aid units will operate under a joint incident command system.



RESOLUTION REGARDING SUPERVISOR'S AUTHORITIES AND DUTIES

WHEREAS, pursuant to statute, the Township Supervisor has the following statutory duties: moderates board meetings; serves as chief assessing officer (if appropriately certified); serves as secretary to the Board of Review; serves as Township's legal agent as authorized and provided for in MCL 41.2; maintains records of the Supervisor's office; develops the township budget and serves as a member of the elections commission; and

WHEREAS, the Township Supervisor has no other authorized duties unless otherwise assigned duties by vote of and approval by the Township Board; and

WHEREAS, the Township Supervisor is only one member of the Township Board; the Township Supervisor's vote is equal to that of all other Township Board members and the Township Supervisor has no more authority over Township functions or activities than any other Township Board member; and

WHEREAS, while the Township Supervisor may be the executive officer of the Township Board, this means that the Supervisor has a leadership role within the board, not an executive role within the Township; and

WHEREAS, on several occasions, the Township Supervisor has acted in ways that are outside the scope of his statutory authority and duties; and

WHEREAS, on several occasions, the Township Supervisor has used his elected position to represent his views and/or opinions on an issue of interest to the Township as being those of the Township Board, despite not being authorized to do so by the Township Board. By way of illustration, such issues include, but are not limited to the Cuddy Drain, Gun Lake Drain, Whispering Pines development, England Point Street repair, the Island Drive dredging project and communications with the DNR regarding trail access for jeeps; and

WHEREAS, the Standards of Conduct for Public Officers and Employees, PC 196 of 1973, as amended, provides that a public officer shall not represent his/her personal opinion as that of an agency; and

NOW THEREFORE BE IT HEREBY RESOLVED THAT the Township Board specifically directs the Supervisor that, from this point forward, he shall not represent his personal views and/or opinions on issues of interest to the Township to the public, county agencies, other governmental agencies or to the media as those of the Township Board, unless the Supervisor is specifically authorized to do so by a vote of the Township Board;

IT IS FURTHER RESOLVED THAT the Township Board specifically directs the Supervisor that, from this point forward, he shall not use his elected position to any personal benefit and/or in

any other manner that is not in accordance with the Township Board's approved position on an issue or matter;

IT IS FURTHER RESOLVED THAT the Township Board specifically directs the Supervisor that, from this point forward, he shall not represent Yankee Springs Township at County Drain Commission meetings, County Commission meetings, meetings with the DNR, meetings with the County Road Commission, meetings with neighborhood groups, meetings with surrounding municipalities unless directly authorized to do so by vote of the Township Board;

IT IS FURTHER RESOLVED THAT the duties of personnel director shall be assigned to the Township Clerk and that the Township Board has determined that no additional compensation shall be awarded for the performance of these duties.

IT IS FURTHER RESOVLED THAT the supervision and interaction with the Township's fire department (including any contracted fire services) shall be assigned to the Township Board's Fire Committee.

IT IS FURTHER RESOLVED THAT the Township Board considers the Supervisor's continued actions outside the scope of his statutory duties or other duties approved by an affirmative vote of the Township Board to be *ultra vires* actions and clearly outside the scope of the Supervisor's authority;

IT IS FURTHER RESOLVED THAT should any charge be brought against the Supervisor or the Township as a result of any of the Supervisor's unauthorized, *ultra vires* acts, the Township Board hereby states that it does not intend to indemnify or defend the Supervisor against any claim. If civil or criminal penalties arise out of such activity, the Township Board will not indemnify the Supervisor.

IT IS FURTHER RESOLVED THAT the Supervisor should be aware that governmental immunity does not protect the highest level executive of a governmental entity if that official acts outside scope of his/her authority.

IT IS FURTHER RESOLVED THAT all resolutions or parts of resolutions in conflict herewith are hereby repealed.


