# ATTORNEY CLIENT PRIVILEGE CONFIDENTIAL

Board members: in response to the email below, Clerk Lippert called me and asked me to review the information submitted requesting an extension of the preliminary subdivision plat for Shalinda. I have now done so.

Geoff Moffatt is requesting an extension for final preliminary plat approval until 1/16/2022. In his letter, Mr. Moffatt explains the following:

- 1. Final preliminary plat approval granted on 1/17/2018 for 2 years.  $\sqrt{\phantom{a}}$
- 2. On 10/10/29, the Board allowed the extension of final preliminary plat approval to 1/16/2021
- 3. Because of COVID 19 mandatory delays, only part of the utilities and improvements have been installed:
  - a. INSTALLED: sanitary sewer, water main, hydrants, site clearing for future surface water drainage.
  - b. STILL TO BE COMPLETED: supplemental storm sewer pipe for extraordinary storm events, contouring for storm water basins, grading and compacting for road base, top coat
- 4. Geoff Moffatt is requesting an extension of preliminary plat approval for another year, to 1/16/2022. His letter provides details on the reasons for delay.

Final preliminary plat approval allows a period of time for the developer to install the utilities and required public improvements. Here, the developer has installed many of the required public improvements already, including sanitary sewer and water lines. There is not much more to do. Arguably, delays resulting from COVID 19 were unexpected.

Last – Attorney meyer asked me if Larry Knowles could vote on this issue. My answer is that Larry can vote on this issue. A board member has a duty to vote. They cannot abstain unless there is a conflict. There is no conflict here for Trustee Knowles. There is a conflict for Trustee Vandenberg. Please see pages 154 to 155 in the new Red Book for further information.
