Mr. Seiler mentioned if you have two lots, not combined into one tax ID, then that individual has to pay twice as much as the person with a combined parcel. J. **Nick Klumpp** – requested 5 years for the time period of the assessment.

**Mark Englerth** commented on 3% for 5 years.
