Vivian Conner announced that she will be running for a Commissioner seat.

Ruth Hubbard, of Barlow Lake, commented on the improvements Mike Cunningham has made in regards to the Barlow Lake Association. Hubbard highly recommended Cunningham for the Trustee position.

Cathy Strickland, Secretary of the Planning Commission, Zoning Assistant, spoke on behalf of Shane VandenBerg to fulfill the remainder of Mary Cook's term as Trustee.

Dave Middleton, Fire Chief, supported Shane VandenBerg as well.

NEW BUSINESS: Candidate Interviews

Mike Cunningham visited the area all of his life. In 2009, he built year round on Barlow Lake and retired in 2010. Yankee Springs and Barlow Lake are in his blood. He has an executive MBA from Purdue. He has been a project manager, department manager and plant manager (of two plants) as well as a technical manager in his job. Cunningham has learned to make decisions on fact and not emotions. His reason for wanting the position is to get more involved in the community. Cunningham is currently involved with the Planning Commission, Veteran's Memorial, election inspecting and Barlow Lake Association.

Shane VandenBerg thanked everyone for their support. Commented that he is in the building industry and has worked for hundreds of people in the community. He doesn't have to go back to jobs because he gets it right the first time. He feels he can bring this same work to the Board. VandenBerg has run for office twice, he is not a quitter and will keep trying. He said that trying is what it is about, not winning. He will congratulate the winner of the Board seat if he doesn't win the appointment. He doesn't like bragging about himself or pat himself on the back.

Paul Heystek commented that Mary Cook will really be missed, and asked that Mary and her husband be kept in our prayers. Heystek has been involved in FEMA and Gun Lake for the last four or five years. He has saved people money through his efforts. Heystek assisted Bob Lippert and gave credit to Bob Lippert for working to take over 400 parcels out of the flood plain. Heystek worked for AT & T for 30 years. He also served as Executive Vice President and President of Local 4039 and was one of two Republicans there. Heystek is now retired. Yankee Springs has been in his family since 1967 when his parents bought a place on Robbin's Bay. He and his wife built year round in 1997. As ZBA Chair, Heystek and the ZBA have had to tackle some major subjects. Heystek has also been involved with the fire pit issue.

Roger Rottschafer, was unable to attend tonight's meeting. Jan Lippert read a letter from Rottschafer dated April 4, 2014. In the letter, the following items were mentioned: Rottschafer has been in business management since 1979, he has brought his trucking company from a few employees to over 250 employees and over \$50,000,000 in sales in 2013, valuable managerial background, took charge of the Lynn Drive Improvement Project, acquainted with local business owners and township employees, also involved with the committee for Payne Lake Water Quality, Rottschafer and his wife are full-time residents of Yankee Springs, and his children and grandchildren are full-time residents of Yankee Springs. At the conclusion of Rottschafer's letter, he strongly urged the Board to consider him for the position as he is ready and willing to serve.

At this point in the meeting, candidates were all asked the same question:

Questions for Candidates

<u>NEW BUSINESS:</u> Candidate Interviews

Question #1: What unique talent can you bring to township government?

Mike Cunningham: Cunningham commented that he felt he was a jack of all trades, but master of none. He brings no particular issue that he wants to address. He wants to make sure the township is doing what it is supposed to be doing, and doing it well. Cunningham would like to focus on the gaps and wants to concentrate on "getting our house in order". Cunningham, in regards to talents, feels he has a pretty broad base with his education, training and career.

(At this point, Supervisor Englerth clarified that Matt Spencer was not interviewing for the Trustee position. Clerk Lippert confirmed that Spencer had not applied for the position by the published deadline that appeared in the Sun & News. The deadline for petitions for circulation of the position of Trustee and for an Affidavit of Identity is April 22, 2014.

Shane VandenBerg: VandenBerg commented that he felt he brought courage to be different than many people. He pushes the envelope, and asks the hard questions. He added that he has gotten "beat up" for it. VandenBerg commented that he can't help it, that's the way he is put together. He is a "Yankee Springer" and he is going to have an opinion and when he comes to a meeting he basically demands that his opinion be heard. He encouraged others to come to meetings and voice their opinions. His opinion may not always be right but he should have a right to express and get a little input from the people in positions of leadership.

Paul Heystek: Heystek commented that one of the Trustee's responsibilities is to research topic and get all the facts to make a fair and equitable decision, and not just "wing it". Heystek feels he has a proven track record for getting that for the board in the past. Heystek commented that he has always been a" team player" and that continuity needs to be on the board to get things done.

J. Lippert asked Shane VandenBerg regarding the signature on his application (was not his). VandenBerg had a work deadline to meet and his signature was written on the application for him by another person.

Englerth commented that he had consulted the township attorney and it was permissible to have questions from the audience that would be asked of all of the candidates.

Greg Purcell, member of the Planning Commission, asked the candidates what their perspective was on maintaining the Planning and Zoning function at the township level versus giving this responsibility over to the county.

Paul Heystek believes in local zoning. "Every time you remove a step, there's less of a personal contact," noted Heystek. Heystek mentioned that with all of the lakes in the township, it is a unique situation with different needs than other communities within the county. If local zoning is removed, the township would fall under a bigger umbrella that would not suit Yankee Springs' needs. Heystek is definitely for local zoning. He felt that the Planning Commission is on the right track with the work it is doing now.

Mike Cunningham agrees with Heystek. Cunningham also mentioned the uniqueness of Page 3 of 8 the township with its amount of lakes, water and state land/parks.

Questions for Candidates

Cunningham commented on the messiness of some situations at times, and it takes work continued and some "messiness" to get to the right answer. To Cunningham, it seems a world of difference to stay with township zoning (a smaller venue and neighbors) rather than go to Hastings to have to deal with things and have a rule changed. Cunningham is wholeheartedly in favor of township zoning rather than county zoning.

Shane VandenBerg recalled the Planning and Zoning board and township board had previously looked into the possibility of township vs. county zoning. VandenBerg's perspective, it was worth the investigation. He would like to see "term limits". He has felt a sense of fairness being adopted by the board in the last five years. VandenBerg mentioned having to sue the township regarding zoning. The township decided to settle before going to trial. VandenBerg commented on the growth of his and his father's business. Growth is needed to sustain our children. He commented that at this point of time, he has had a change of heart because he has watched the Planning Commission as a participant and feels that they are doing a good job. Complimented Mike Cunningham that he has done a good job.

Planning Commission: Fiala commented that the PC is near completion with the Sign Ordinance. Also, Article XII is in the final process to bring it to Public Hearing. Fiala also commented that a Professional Planner is needed to bring the PC's work to the point of codificiation. Rebecca Harvey has been highly recommended as a Professional Planner. Prairieville Township has been happy with Harvey's work. General consensus from the board was approval with the direction the PC was going. J. - <u>Fire Service Contract</u> the contract has not been signed yet. M. Englerth has recently met with M. Bremer and A. Jansma. Items still need clarification and need to be addressed. If contract is not signed, the township still has service at the same rate.
- Public Safety: Englerth mentioned several concerns that need to be addressed. The recent ice storm was a wake up call. The township could be better prepared. The township needs to know what resources are available. Englerth mentioned preparation for ice storms, tornadoes, etc. Sirens are
