S. Smith represents the Health Department and announced that January was Radon Awareness Month. Radon is an odorless, tasteless gas. It is the second leading cause of cancer. Free tests are available. Literature on this will be sent to J. Lippert to have available in the township office for the public.

Randy & Dawn Sharp/Owners of Paradise Pizza, 11446 M-179, were informed that the flags that they have in front of their business were in violation of the township's ordinance. Sharp's have been the fourth pizza place in the building and they commented that they would like people to know that they are there and open for lunch. They would like to know what they can do to resolve this, and asked for clarification of the sign ordinance. M. Englerth received a letter from the Sharp's asking for clarification of the signage. Campbell, Trustee, asked if the Sharp's noticed a change in business since the flags were down. Dawn Sharp said that when flags were up, their lunch business almost doubled. Randy Sharp commented that the customers liked seeing the flags and he hasn't had one complaint. He remarked that the flags are not trashy (looking). R. Lippert, Zoning Administrator, commented that the Sharp's were very courteous when asked to take the flags down and he was surprised that the flags were up again.

Jerkatis inquired as to why the flags were not approved in the ordinance. R. Lippert commented that there is a proper way to seek approval for the use of flags, and that is to go before the ZBA and ask for an interpretation. They can go to the Planning Commission to ask it to consider amending the ordinance. J. VandenBerg commented that it should be a priority at the Planning and Zoning level to change this ordinance. S. VandenBerg told the Sharp's, "You've got a lot of good people pulling for you."

Orr commented that it would take time and a site for the memorial is needed. WALKABLE COMMUNITY: Mick Barney, of Orangeville was present at the meeting to talk about a project he has been working on for a year now. He is a committee of one. He would like to have a walkway around Gun Lake. M. Barney commented that a grant is available from the Michigan Dept. of Transportation to fund roughly 60% of the cost of the proposed 15 mile walkway. Barney mentioned that Weick's and Baypointe are "in" with the project. M. Barney is looking for a letter of support, not financial support.

**OPEN MEETINGS ACT:** M. Englerth distributed the Incident/Investigation Report. Discussion occurred including board members named in the report. The incident reported involved three board members checking out the completion of the recent renovation/parking lot project. M. Cook commented that the intent was not there to do anything wrong. In review to prevent further issues, an 18 hour notice will be given prior to a meeting and all board members will be contacted. It was noted that every time three elected officials are in the office, the appearance can be given of a violation of the Open Meetings Act. Referring to the incident report, M. Englerth commented that a board decision was not made, but he wanted to be honest and transparent with those in attendance of tonight's meeting. Fiala added that if four members of the PC go to a conference, they cannot ponder an issue and cannot make a decision. At a recent MTA workshop, M. Cunningham (PC) commented that they were advised to keep conversations to "grandkids and the weather" when with a majority of PC members. M. Englerth concluded the discussion with the comment, "We do take it seriously and will do so more in the future."
