PUBLIC COMMENT

Jackie Schmitz, YS Township

John Jerkatis, Treasurer

John Jerkatis, Treasurer, commented that he doesn't want what he has to say to come across as derogatory to the Veteran Memorial Committee. He commented that most were innocent by-standers with maybe a small exception. Jerkatis mentioned that he was tardy at a previous meeting (5-22-13) in which the minutes were approved and he failed to pick up on what actions were to take place on June 29 & 30th regarding the work days of clearing land for the Veteran's Memorial. Jerkatis takes full responsibility for being late and missing the motion. Jerkatis mentioned that he happened to go by the work site at the Fire Station on June 29th. He noted that many trees had fallen and he didn't see one hard hat on anyone. Jerkatis also noted that he did not know if Miss Dig had been called as he felt the operation posed a very real liability. Jerkatis distributed a small packet of information to each board member. The packet included pictures of aerial views and some of timber. Jerkatis inquired as to where all of the wood had gone. It was confirmed that volunteers who helped with the project had taken the wood. Jerkatis mentioned that a full cord of wood goes for \$100 and he figures the area cleared contained \$9,800 worth of wood.

Jackie Schmitz, YS Township resident, thanked Mark Englerth and Mary Cook for attending the meeting about ordinances with presenter Liz Kirkwood. The meeting

was in regards to fracking and township ordinance possibilities relating to fracking.

J. Schmitz inquired to see if any action had been taken by the township since the meeting. M. Cook commented that she hasn't been able to pull up the information regarding the ordinances that was presented due to the township computer server being down. M. Cook also commented that they haven't been able to do anything until they have something to look at. J. Schmitz provided copies for M. Cook and

M.Cook will make sure they will be distributed to other board members.

However, Jerkatis feels that safety issues were the primary concern. Jerkatis asked YS Township Legal Counsel, John Lohrstorfer, what the township government should do to rectify the errors of its ways and what should the township government do to prevent this from ever happening again. J. Lohrstorfer commented that he would look into it, and what has been done is done. Lohrstorfer mentioned that generally a township can't just get rid of assets of the township in regards to the wood.

Jerkatis made a motion to temporarily halt all activity on the Veteran Memorial site.

Mark Englerth, YS Supervisor, commented that he had contacted different logging Mark Englerth, YS companies regarding the wood. One of the contacts said the wood had no value except for firewood. Also, it was mentioned by an audience member that the quote of \$35 to \$40 per cord seemed to be more likely.

Englerth commented that he couldn't be more proud of the community. He commented that Larry Knowles and Shane VandenBerg are experienced equipment operators and donated their time and equipment. Englerth noted that no one acted inappropriately. Volunteers were divided into work teams which were properly supervised. No fiberoptics were hit.

PUBLIC COMMENT cont'd:

Englerth continued comment that regarding the wood, they wouldn't have allowed \$10,000 worth to leave the township property. As for inmates working on the project, Burnham & Flowers Insurance Agency was contacted and the township was covered for incidental projects. Hours were put in by volunteers and the experienced individuals. The Zoning Administrator, Larry Knowles, supervises a 20 man crew, put in two – 16 hour days. Others in attendance who volunteered were impressed with the inmates who worked with them. Jeff Garrett of Valley Drive and Pat Jansens of the ZBA, both made positive comments regarding the inmates.

Jerkatis also commented that logging was the second most dangerous occupation in the U.S. David Middleton, Fire Chief, volunteered at the clearing and had his safety equipment on as well as his son, wife and grandson (having their safety equipment on). D. Middleton also commented that a standing cord of wood goes for \$20 a cord. Middleton noted that there was never a close call. They weren't falling trees. They were digging and pushing trees over. Referring to logging being the second most dangerous occupation, Middleton commented that according to National Standards, fire fighting and farming is #1 and #2. Middleton felt that the site needed to be cleared for the safety of the people in the park. He added that when the project is done the community is going to have a nice park and part of the community. "The place was left cleaner than it was found. They were in no danger at anytime. "In my humble opinion, the job was done well and done right," stated Middleton.

Discussion continued regarding the disposal of stumps and debris. Frank Fiala, PC Chairman and Road Commissioner spoke to the DNR about the stumps and maybe Frank Fiala, PC Chairman they would be interested if the stumps were pulled out and lined up. The Road Commission just doesn't have money to do this work.

Shane VandenBerg commented that they did a terrific job and it is done. S. VandenBerg did not appreciate J. Jerkatis saying that the volunteers were unsafe.

Randy Knowles commented that hundreds of thousands of men and women down through the years have been killed, lost limbs, dealt with agent orange, etc. R. Knowles can't think of a better use for the property designated to the Veteran's Memorial.

Larry Knowles, ZA, commented that people were on site that day because they wanted to be there. L. Knowles mentioned that he had a riot working on June 29 & 30. Knowles noted that a fallen tree at the Township Park was taken care of as well. Larry Knowles, ZA M. Englerth added that the trees on the east side of the park posed a greater threat than the work done on the Veterans Memorial site. Englerth reiterated how proud he was of the work that was done. He also commented that how people make a contribution to America is their choice. He encouraged residents to help out when they see a problem.

The motion made earlier by Jerkatis to temporarily halt activity on the Veteran's Memorial site failed due to lack of support.

Mary Cook, Trustee, commented that she was aware that Mark Englerth would like the position of Yankee Springs Representative to the Gun Lake Improvement Board. She noted that J. Lippert should have been notified of M. Englerth's intention beforehand, and that M. Englerth already puts in 50 hours a week. M. Cook would like for M. Englerth to continue to use his talents on the Cuddy Drain and other major issues and have J. Lippert continue on as the YS Rep. to the GLIB. M. Cook felt that the GLIB works more with weed control for Gun Lake.

Englerth commented that he had nothing against J. Lippert. Englerth mentioned previous GLIB meeting absences of J. Lippert and added that he was looking for continuity. Englerth mentioned some items such as the catch basins involved with the drain costing \$10,000 a year for maintenance.

Payne Lake Creek being impeded as issues involved with the GLIB. *

Jan Lippert commented that she was in constant communication with the Improvement Board. She also commented that the GLIB is a separate entity. The Board consists of the Allegan County Drain Commissioner; Barry County Drain Commissioner; one representative each from County (s) Board of Commissioners; representatives from each of the four Townships that "touch" the waters of Gun Lake; and the Gun Lake Property Owners Association.

Lippert announced that there will be a GLIB meeting (Public Hearing) on July 13 at the Gun Lake Chapel at 10:00 a.m. regarding the five year weed assessment renewal.

Motion by M. Cook with support from Jerkatis to allow J. Lippert to continue YS representation on the Gun Lake Improvement Board. Roll Call: Jerkatis; Cook; Campbell; Lippert YES. NO: Englerth. MOTION CARRIED.

Sue Roush, Cemetery Sexton represented the Rousch family at tonight's meeting. The Roush's are the sextons for the five Yankee Springs' cemeteries. They have been doing this work since 1967 or 1968.

Motion by J. Lippert with support from Jerkatis to accept the contract with the Roush Family, Cemetery Sextons, for budget year 2013-2014 for the amount of \$14,970.00 for a total of 12 monthly payments of \$1,247.50 payments. ROLL CALL: Jerkatis: yes, J. Lippert: yes, Englerth: yes, M. Cook: yes, Campbell: yes. All Yes – 5. MOTION CARRIED.

J. Lippert mentioned work on Robbin's Cemetery to be done. Discussion also took place on putting this work out for bid, in order to be transparent with taxpayer's money. Board members clearly stated that they had nothing against the Roush's work. J. Lippert confirmed the workmen's comp certificate was on file for the Roush's and that they have been the Township's Cemetery Sexton for 45 years. Dave Middleton made comment that the township could check with its auditors about competitive bidding.

He added that he believes the township has the right to go with the highest bid (or
