Page 1 of 6 YST BdTrustees Prior to the opening of the public hearing portion of the meeting, McCrumb and the Board fielded questions from Warren Wheeler, PUBLIC HEARING Theresa Wheeler & Don Berry. Most of the questions dealt with the procedure of the hearing, and the approval and adoption process of the budget for 2012-2013. The Wheeler's asked about the General Fund and its relationship in amount to other townships of similar size. It was confirmed that Yankee Springs Township had reserve funds to operate for approximately one year (give or take). It was also confirmed that Yankee Springs reserve fund was in good standing financially to comparable townships.

A. McCrumb reviewed the General Fund Budget of 20 and told those in attendance that the General Fund Budgets are being adopted by function and not by line item, We Crumb thanked Alice Jansma for her work in preparing all of the budget information.'

Theresa Wheeler, YS Resident, spoke of "wants vs. needs". She inquired as to why \$40,000 was being transferred to "Park Fund" and "Park Operation" (\$20,000 each). Discussion occurred regarding the use of funds to operate the park and the possibility of uncoming projects that may take place at the park (such as a restroom). It was noted that the transferred funds were not always used, but they were budgeted for in the yearly budget.

Warren Wheeler, YS Resident, commented that the county is not spending that kind of money (YS Township's budgeted amount) for park maintenance.

M.Cook, Board Trustee, commented that sometimes the auditors of the township suggest these fund transfers and every municipality needs to do this by law.

Theresa Wheeler commented that she thought \$20,000 was too high.

Theresa Wheeler, mentioned the amount of approximately \$48,000 under "Assessor" in General Government. T. Wheeler commented that the assessor was in the YST office for one or two days a week. Alice Jansma, Deputy Supervisor, commented that the total amount is for the office of the Assessor (not just the salary of the Assessor). Regarding this topic, Warren Wheeler asked for a little more elaboration on this. W. Wheeler commented that he felt the amount budgeted to the assessor was still high and he'd like to know how many hours the assessor put in. A. Jansma commented that according to MTA (Michigan Township Association) reports, the YST assessor is right in the average area of pay for assessors.

Warren Wheeler inquired about the amount budgeted for professional services such as engineering and attorney fees. It was confirmed that those services were in the line item "Administration" under General Government and budgeted for \$27,300.
