Motion by Jerkatis with support from Campbell to raise the cap on the township's Special Assessment allocation from \$150,000 to \$200,000. Roll Call: Jerkatis: Yes, J. Lippert: Yes, Englerth: Yes, Rottschafer: Yes, Campbell: Yes. Yes: 5, No: 0. MOTION CARRIED.

David Minnaar, of Elmwood Beach – commented regarding his request to rescind the current administrative fee of 1% of the tax bill and/or replace it with a flat fee that D. Minnaar feels makes more sense. He had hoped this would be changed before the 2015 taxes but it wasn't taken up. Minnaar asked why the board/twp, suddenly needed it (the 1% Administrative fee), and what are the actual costs involved in producing the tax bills (twice a year). He can't imagine it takes the cost of his 1% property tax to produce a bill. D. Minnaar felt it was not fair to charge by use of percentage per parcel to charge for the cost of producing a bill. In essence, D. Minnaar felt that "a percentage is tantamount to a millage without voter approval. Any percent of tax fee is a millage. You can't argue your way out of it." Minnaar also noted that in the tax bill - township operation budgetthe tax millage of Yankee Springs Twp. is about .89 mills. "The administration fee is the equivalent of .32 mills. That's a huge increase. Now if the operating budget isn't sufficient to cover the discretionary funds like mailing the bills, then I would like to understand why the cost is so great that requires .31/.32 mills. I guess the bottom line is I'm saying a percent of tax is a totally unaccepted way from my common sense point of view of doing business to recoup a cost or as state law says "to offset (not eliminate)

sts associated with" which the Board has discretion to not charge anything at all as it mas been previously." Board discussion occurred. D. Minnaar commented that it doesn't have to be a 1% on property tax. Discussion occurred on the law provision regarding a flat fee.

PUBLIC COMMENT: (Limit to 3 minutes)

Alex Middleton was present to address the proposal for the fire coverage request of Wayland City Council. A. Middleton, read a statement entitled: "Statement regarding the possibility of transitioning fire coverage for Yankee Springs Township to Wayland Fire Department 10/8/2015. ***Please find this document attached to minutes.***

Rottschafer commented noting concerns of confusion of information regarding the hopes in getting the YS Fire Station Building up and running.

Since time had expired for public comment, Englerth offered an invitation to A.

Middleton to come to the Fire Committee with the questions that he would like answered.

A. Middleton asked that he could finish his questions. Middleton's request was allowed.

Scott Havens – of Gun Lake Sprinkling takes care of the park and township's sprinkling. Havens noted an issue that caused a need for a T- bar. S. Havens wanted to know about repairing the situation that occurred at the Park. Englerth commented that "we will get a new valve and get it done."
