ACKNOWLEDGEMENT OF VISITORS:

County Commissioner Catherine Getty provided an update on the Barry County activities. Highlights include the following: approved an MDOT application for relocation of a drive, equalized values for the county, updates to audio & visual, and they did away with the COA (Commission on Aging). The Household hazardous waste collection was held on May 2nd. Annual reports were given by the Drain Commissioner, the new Zoning Administrator, and Eric Thompson with PCI. The Commissioners tabled a significant fee increase from PCI.

Nancy Whitley: Nancy is with the Wayland Community for Gun Safety group. Their goal is to get guns out of the hands of kids. They have reached out to local police and the local public schools. The group provides free gun locks and handed them out to attendees. They also have free bumper stickers and yard signs. She invited Yankee Springs Township Board members to attend their quarterly meetings. They were initially funded with a grant and are looking for new funding.

Mr. Heethuis thanked Nancy for her presentation.

PUBLIC COMMENT:

Mike Cunningham (Heritage Bay Dr): Tonight's agenda contains a proposal for cost recovery for the fire department. Mike disagrees with these fees and has emailed the Board members. He feels the township residents pay for this service through the millage. The discussion and information from the board has been limited. He is unsure how these fees will be used. He is asking why this is needed? He doesn't feel that lift assists should be handled by the emergency services. He hopes for a good discussion tonight and that any resolution will properly describe all relevant information.

Robin Laansma (Payne Lake Rd): Robin feels we need to stay out of all of this 'gun stuff'. Robin does not feel that is a township role. She feels it is a personal agenda and the township needs to stay out of it.
