Mike Cunningham, Heritage Bay Dr. A mining ordinance is not a simple matter. State statute does not allow a township to prevent gravel mining from any property unless very serious consequences buld result. I do not agree with the state on this. The Barry County ordinance does look like a good

ctarting point, but it could be better. I have sent suggestions for improvements of our township ining ordinance to the PC and the Board. Some of the suggestions I have made are: distances separating mining activities from residential dwellings and property lines, a five day/week mining operation from 8 am or 9 am, shutting down at 4 pm, shutting down for holiday long weekends.

John Trygier, Barlow Lake Road. I sent an email to the PC with suggested recommendations for the mining ordinance. I have reviewed 8 other township ordinances and reviewed the zoning map and other pertinent documents. Recommendations: 1) provide a more detailed description of the review and approval process. I believe it is important that Special Use applications that result in permanent change to the Township should have final approval by the publicly elected officials. I'd recommend this approval process be added to the Landfill special use application process. 2) Recommended documents to be part of the application process include: a. Hydrogeological study, b. Topographic and Geological Analysis, c. Noise/Vibration study, d. Traffic Impact Study, e. Air Quality Analysis/Dust Control, f. Endangered Species Impact Study, g. Economic Impact Studies, h. Operational Plans, i. Site Plan Requirements, j. Other agency required permits with approvals as part of the application.

**Charlene Silliman**, Heritage Bay Dr. What is a safe distance from the lake? Does anyone know? Ann Arbor has lost their lake and wells. What will you (PC) do to protect us? We have to save our water. Charlene shared concerns about gravel mining close to the lake, water tables, environmental impact studies, air quality, and trucks. I appreciate your work. We are willing to help.

Discussion of the Mining Ordinance.

Ms. Bush thanks all who have sent emails and shared ideas and/or suggestions with the Planning Commission regarding mining in the township.

The PC went through the working copy of the Mining Ordinance: Yankee Springs Township, Barry County, Michigan, Draft No. 2. The committee has worked on this mining ordinance. Jim McManus, Township Planner is present tonight.

The PC members suggested changes to several sections of the document including an elimination of the small pit removal language and Section 2. Discussion also included a designation of mining operations no closer than 1000 feet from any RSF, RLF, GLRLF, SR, RR, RMF, or MHC zoning district, or Residential PUD district; number of copies of applications required; mining rotation of ud in sections of active mining and reclamation of land, and signage.

Tim McManus pointed out two areas of potential challenge to the Draft Mining Ordinance: 1) Hours operation, we are pushing for 7:00 am to 5:00 pm; 2) Surveillance Fee - an annual fee to defray the Township's costs.

Questions were raised about the roads and mining traffic. Mr. McManus explained that there is a measuring system that determines the quality of the road, so at the beginning of the project the traffic impact study would speak to that. Every five years there is a review which would include road conditions. In general, if the road can handle other truck traffic, you cannot discriminate against it. Oshtemo Township, however, has passed a law regarding limiting use of roads, and maybe YS can consider that. We can consult our lawyer on this to see if additional requirements can be put in place. We must work with the Road Commission for bonding. As far as escrow fees are concerned, there are 2 levels; one for upfront costs (surveys, studies, lawyers) and then the bonding process based on acreage, tonnage planned on removing, etc. There are two levels of protection for the township.

Observation by the PC: Yankee Springs is a residential, recreational township. YS is a unique township with much state owned land as well. A question was raised on whether any aspect of that uniqueness can be used here. Mr. McManus noted that in any gravel mining operation, there are two considerations. On the back end there are the very serious consequences, but on the front end you can look at the regional aspect and ask, is the product unique to this location and is there a need (limited supply)? When we look just north and south of us there are big gravel mines - maybe this can be used in considering the application.

#### Path forward:

- The attorney will be consulted on several topics for her recommendations.
- At next month's meeting the PC will review this document again. The December PC
  meeting, Dec. 18, at 7:00 pm is recommended for a Public Hearing or Open Forum to hear
  from residents and receive feedback to the proposed Mining Ordinance.
- We will have the buffer analysis (1,000 ft from residences) done to make sure the proposal is reasonable.
- Section 2, Small Pit Removal, will be eliminated.

#### Discussion of the Master Plan.

Community input on the Master Plan will be gathered in an Open Forum at our November meeting. Ms. Bush will send the copy of the current Master Plan to Jim McManus.

Many are retired and enjoy the peaceful, recreational atmosphere. He suggested using escrow throughout the process so township residents don't have to pay.

Our experience with the other mining operation at Payne Lake Rd was that the crusher was working all the time. Suggest putting restrictions on hours of operation. Mike Keyes, Heritage Bay Drive. My biggest concern is that Barlow Lake is 100% spring fed, and we feed Payne Lake and Gun Lake. Drying up the lakes needs to be considered. Charlene Silliman - Heritage Bay Drive. In regards to the gravel crushing and rinsing, she has done research on the State of Michigan site regarding requirements and fines for violations. She shared concerns for the trees on the hill (Heritage Bay Drive), water runoff, wells, and sewer of nearby residents. Robin Laansma - YS Precinct delegate. We live next to the two pits on Payne Lake Road. I suggest looking closely at operational start time - when trucks can start, crushers start, etc. Make it clear about the distance from the property line, green space, and berms. Have plans to follow up with violations immediately and retain the ability to revoke permits. Thank you for your time on this. Ms. Bush invited input from residents via email noting that they value this feedback. Public Comment closed at 8: 53 pm.
