The budgets have been amended based on the changes that were agreed to in the workshop on June 16.</li> <li>• The taxable value of our township is \$434,287,084 from the warrant of the Assessor.</li> </ul> <p><b>Mike Cunningham</b> (township resident): He states that the budget is too high as it once again includes \$150,000 for the water system expansion. The water system should be self-sufficient and not subsidized by the township. The only benefit to residents not on the water system is the usage of fire hydrants and the township already pays for that. The water system also receives income from Sprint for the water tower rental. He feels that the fund balance is three times higher than it should be. The administration fee should be rescinded.
