Richard Beukema discussed the need for very clear definitions especially in	
regard to living fences and presented the PC with a drawing indicating "vision	
zones". Beukema also offered photos of waterfront landscaping from other	
communities.

Greg Milliken outlined the alterations to the most recent draft and specifically	
addressed the following issues:	
1. Treating like a PUD vs. SEU – not recommended as gravel mining does	
not have much room for give and take. An SEU provides protection for	

both sides.

2. Setbacks are they too large? Will there be legal challenges? 500 foot is only when the gravel mine is adjacent to a residential district.

3. Discussion regarding the water table and leaving a 4 foot buffer above the water table. Original studies show that it is acceptable to dig within 4 feet, but if deeper digs (below the water table) are needed, then more detailed studies are required by the ordinance.

Public hearing was opened at 7:45 pm. A page-by-page review was undertaken.

- Shane Vandenberg questioned how it would work if an individual wanted to dig a pond, is the DEQ involved? No answer provided.
- Bill Baughman discussed adding the term wetland or DEQ approved pond.
- Schwennesen discussed the start-up process and is concerned with reserving the setbacks and original greenbelt.
- Review of priorities regarding dust, noise and visual impact in matter of importance.
- Schwennesen advised that he feels crushing and processing are one in the same so why is the setback different discussion.
- Jansens advised he would like to see prohibited operation on Saturdays and Sundays due to the recreational nature of YST. Recommendation to leave the language as is to include Sundays and Holidays.
- Page 6, Paragraph 4 G discussion regarding back-up alarm volume suppressor– strike this wording from Ordinance.
- Stock pile slope of 45 degrees strike wording.
- Access routes should be bonded. Should be handled by the road commission.
- Add language regarding the water table description.
- Tipping Fees need to be updated to today's standards. Milliken suggested that Zoning Administrator or his staff survey other gravel operations in our region to get updated fee amounts. Township Board will need to make resolution to include new tipping fees.
- Discussion regarding liability insurance.

Public hearing was closed at 8:40 pm.

Motion by Purcell to table until the March 17 meeting to allow Greg Milliken to complete the changes for PC review. Second by Schwennesen. Approved by all. Motion carried.
