- Locations and sizes of all existing sanitary and storm sewers, existing county and private drains, cross culverts under existing roads, and other underground structures within the development or immediately adjacent to it.
- Locations of other above-ground or below-ground utilities within the development or immediately adjacent to it.
- Site distance plan and profile at each intersection of a proposed subdivision street with any existing or proposed public road or street.
