- Commissioner Getty and Commissioner Bassett shared the activities taking place at the county level.
- Mr. Bryker gave his report from the recent GLIB meeting.
 - The board approved treatment of 43 acres for two invasive plants curly leaf pondweed and Eurasian milfoil, with two herbicides and to treat for algae control in the channels with Peroxyhydrate sodium carbonate. This is a very safe algaecide.
 - The state campground lagoon is to be treated with the same two herbicides to treat the Eurasian milfoil.
 - Three acres in the southeast corner of the lake are being treated for Eurasian milfoil.
 - No copper-based algaecide is being used as they are banned for use in the months of May and June by EGLE.
- Coach Madelynn Lula made a presentation to the Board regarding a potential fundraiser she would like to hold at the Yankee Springs Township Park. The cheer program at Thornapple Kellogg has grown significantly and the needs of the program also grow with it. The proposed fundraiser would be a pickleball tournament with additional activities for community members. The volunteers would be on hand to ensure proper treatment of the courts, clean-up, etc. The proposed date is August 2. Supervisor Heethuis indicated that this will be put on the agenda to vote on at the July board meeting.

Zoning Department:

 On Tuesday, June 10, the Barry County Court judge ordered that the VanderKam property on M179 be brought into full compliance with township ordinance by October 12, 2025. ZONING DEPARTMENT
REPORT

 Benchmarks have been established to be met with full completion by October at which time the license will be withdrawn.

Fire/EMS Report:

- May 2025 Fire/Emergency Medical responses.
 - o Chief Miller reviewed the report.
 - Eleven fire calls and 21 medical calls in May. Year to date, calls are slightly lower than last year.
 - Eight of the emergency medical calls were responded to by the duty shift and the remainder were responded to by medical first responders during their off time.
 - Up to 20 personnel on the department: 16 certified fire fighters and one probationary fire fighter. Eight of the personnel are emergency medical responders, three paramedics and three EMTs.
 - Reviewed the training that was conducted over the last month.
 - Have had the fire truck since September and are ready to start mounting tools to it permanently.
 - Working with Thornapple Ambulance is going smoothly.
 - Mr. VanHouten requested that a cost recovery program for power lines be in the plans as soon as possible and Chief Miller said they will be looking at it.

Park Committee:

- · Work is continuing on the pickleball and basketball court renovation.
- It is expected to be completed by June 23.

Recycling Committee:

- The committee has been gathering data on pad and bin and strongly recommends that the township add another pad and bin.
- The combination would \$9,323.00. An oversight mini grant program of \$4,000.00 has been approved to offset this cost.
- "Dry runs" cost \$100 each and there have been 25 in the last year. Another bin would eliminate the dry runs and would help recover the cost.
- This will be looked at as part of the budget.

Veterans Committee:

- Need a board member to report on this committee.
- Mick Lane did a great job on the Memorial Day ceremony, added some new things including the tribe. Good things coming up in the future.
- It was great involving the tribe, the scouts, and the community. Attendance was over 130 people.

Clean Water Committee:

- Meeting will be next Tuesday, June 17.
- Yankee Springs water system is looking at possibly trying to increase the amount
 of the water they can put out. EGLE says when 80% capacity is reached,
 something has to be done and they have come very close to that number a few
 times.
- Also talking about an Edwin Allen development on the west side of Patterson that
 would bring in 90 homes and they have shown interest in a water system. Our
 system can't service that right now without increasing the arsenic removal system
 and would probably need to replace the smallest well.

providing his reasons for requesting that the township general fund balance be reduced by not imposing the admin fee or reducing the imposed millage because the township fund balance is about \$1 million higher than it needs to be. The township is taking more money from the residents than is needed and this should stop. He also requested that the township not put in the budget any funding for a trail or trail study. It is time to put that on a ballot to see if this is something the residents think should be done. It is also past time for the board to go back to having two public comment periods. The first public comment period should be prior to the treasurer's report and the second period after the board action items. This was a long-standing process for the township and there was no valid reason for it to go away. There was no board discussion and no vote and at the very least someone should explain why this was done.

Robin Laansma (Yankee Springs Township Precinct Delegate): Shared her appreciation and thanks for Deb and all the time she puts into the financial reports. What an exciting night for our firefighters, and she expressed that she is so thankful for all of them. She repeated some of her comments from the April board meeting and email sent to the board. By removing the first public comment, the board has removed the voice of the people. There isn't any opportunity for the public to comment on the agenda or anything else they might like to express before the meeting proceeds. Reinstating the first public comment and keeping the second is the right thing to do. This is very common in meetings such as this one. As mentioned before, she was unable to attend the May meeting and it would be great to be able to watch it online and also good to be able to go back and review meetings that were attended. All the other meetings they attend have a live stream and then the meeting is put up on a platform to be watched at a later date. She urges the board to take a look at this and appropriate the funds to do it.

Dave Laansma (Yankee Springs Township Precinct Delegate): Congratulated the newly sworn fire officers and provided a heartfelt thanks and appreciation for their willingness to serve and the high state of readiness they maintain.

BOARD COMMENT:

Hopkins: The firefighters do bleed red – and to remind everyone that June 30th is the day for the next blood drive. Everyone benefits from this. When I had a heart attack, they were the first ones to my house and five bypasses later, I'm still here. So I thank them for that. And you do get a donut if you donate blood so remind everyone that the date is the 30th.

Knowles: It was a nice meeting and nice to see.

Mousseau: Congratulations to the new officers and a thank you to Travis. We threw a lot at him at the last minute to put all the budget stuff together and that would be very difficult. He did a great job and we appreciate that. Taxes go out in early July.

VanHouten: I thought it was a really cool night. It took a long time and a lot of work for the firefighters to make the move and I'm really proud of all of them. It's working out really well and I appreciate what you do.

Heethuis: In all the board meetings that I've been part of for the last five years, having our own fire department and swearing you guys in, this is big. We're going forward and I'm proud of you all and glad to be part of it.
