**Fire/EMS Report:**

- Review of March 2026 Fire/Emergency Medical responses (given by Trustee VanHouten in the absence of Chief Miller).
  - 47 fire responses which included 29 lift assists. Will be looking into the large number of lift assists.
  - 29 medical dispatches.
  - There were 14 medical calls to Yankee Springs Meadows Park.
- Current personnel are 21, including 15 certified firefighters, 3 probationary firefighters, 6 EMRs, 4 paramedics, and 5 EMTs.
- Training for the month included fire officers meeting, all departmental meeting and safety class put on by Consumers Energy.

**Park Committee:**

- Park is opening up for the year. The nets will be put up as soon as the correct brackets are received.
- New cedar mulch has been put down in the playground. The baseball diamond is going to be refurbished as well.
- Supervisor Heethuis is interviewing two young people next week for the custodial positions at the park. If anyone else is interested please let him know.

**Recycling Committee:**

- No meeting.

**Veterans Committee:**

- The expansion of the Memorial (Phase III) needs to be done before building season starts due to availability of the contractor. Therefore, the committee opted to go ahead with the project and will fund it personally if not approved by the Board.
- Two bids were received and the best price is \$3,000 for the project.
- Designating the Veterans' Memorial Park –this is not a zoning change but a legal name change approved by the Board.
- The size would be approximately 200 x 200 sq feet.
- Being a park will allow the committee to apply for grant funds for future plans.

- Marcia Basset provided report from the first meeting of the year where the chair and vice chair were appointed.
- They approved a newsletter on what was done last year and what is planned for this year.
- Treatments will start soon (probably in May) depending on water temperature, rain levels, etc.

**Board Action Items:**

- Resolution to put on the August ballot the renewal of the Fire/EMS millage – this is the same that has been done for past years with no increase.

- Mining ordinance

**Motion by Heethuis with support from Knowles to adopt an ordinance to amend the township of Yankee Springs Zoning Ordinance to adopt new requirements for planned mineral removal, to provide an effective date, and to repeal all ordinances or parts of ordinances in conflict with this.** Discussion: Trustee VanHouten states that if the Board

decides to pass this, he would like to see added a requirement that the mining company and the Barry County Road Commission have an agreement on road maintenance and the timing of that maintenance. He thinks the Planning Commission did an outstanding job on the ordinance but wondered if they considered not allowing mining at all in the township. He expressed his opposition of the ordinance, which is summarized as follows: Yankee Springs Township’s unique identity—defined by its extensive state-owned recreation land, abundant lakes, dense residential areas, and tourism-driven economy—makes it highly incompatible with sand and gravel mining, which poses significant environmental, economic, and community risks. With over 22% of the township dedicated to public recreation and limited land actually suitable for mining, such operations would threaten groundwater systems, wetlands, and lake levels while degrading air quality and disrupting wildlife habitats. Additionally, mining could reduce property values, harm tourism (a \$25–\$35 million economic driver), increase heavy truck traffic, and strain infrastructure, ultimately lowering quality of life and tax revenue. Given these substantial and often long-term costs—compared to only short-term, limited economic benefits—along with legal grounds for denial under Michigan law, the township has strong justification to prohibit mining in order to protect its environment, economy, and community character. Trustee Knowles expressed that the Planning Commission did consider all these things in drawing up the ordinance and Clerk Hopkins praised the ordinance for being as restrictive as possible. Supervisor Heethuis stated that this is the way to handle it per the attorney and the planner so that any issues will prevail in court. Amendments can be made going forward as needed. **Roll Call Vote: Knowles: yes; Hopkins: yes; Mousseau: yes; VanHouten: no; Heethuis: yes.**

  - Presentation was made at a special meeting and the Board requested a formal contract to be reviewed and voted on at this meeting.

**Motion by Knowles with support from Hopkins to accept the contract with Peerless for \$650,821.40. Roll Call Vote: Hopkins: yes; Mousseau: yes; VanHouten: yes; Heethuis: yes; Knowles: yes.**

**Motion by Hopkins with support from Knowles to approve Resolution 04-09-2026 to establish Special Assessment District #52 for road improvements to Elmwood Beach Road.** Discussion: There are 72 parcels involved. It would be a three-year term with a 3% interest rate. The total cost would be about \$63,540. Including interest, the cost per parcel would be \$882.50. Interest is charged on unpaid balance at the end of each year and the assessment will be added to the 2026 winter tax bill. **Roll Call Vote: Mousseau: yes; VanHouten: yes; Heethuis: yes; Knowles: yes; Hopkins: yes.**

**Mike Cunningham** (Heritage Bay Dr): He was critical of the process that was used to appoint a new clerk in December 2024. The clerk will now have to stand for election in November and the filing deadline for that position is April 21<sup>st</sup>. He hasn't seen the Township doing anything to make residents aware that the position is up for election. He hopes that there will be more applicants for the position.

**Dave Laansma** (Payne Lake Rd., Precinct Delegate): Thanked Dave VanHouten for a very compelling argument and he wonders if there has been an instance in the state of Michigan where a township has successfully denied mining. He appreciates all the work that the PC put into the ordinance as it is as restrictive as possible. It doesn't shut the door completely but makes it much more difficult and sets high standards for cleanup.

**Robin Laansma** (Payne Lake Rd., Precinct Delegate): Thanked Dave for everything he put into his argument. If we could say no mining in Yankee Springs, she would be all for it. She appreciates the current ordinance being as restrictive as possible and expressed appreciation to the Planning Commission.

**Catherine Getty:** The household hazardous waste collection will be held at the Fairground on May 2 from 9 AM to 3 PM. Residents are encouraged to make an appointment online either through Facebook or on the County website.
