County Commissioner Catherine Getty and Marsha Bassett: The commissioners gave a brief overview of recent meetings at the county, including the purchase of software for vital records, human resources, and finance departments. They passed a Memorandum of Understanding with the steering committee to establish a Thornapple River Trail going from Nashville to the Grand River. There was also an agreement signed between the County and the United Way for the provision of some veterans' services. PUBLIC COMMENT: Mike Cunningham (Heritage Bay Dr): Mr. Cunningham stresses that following proper	PUBLIC COMMENT
procedures is essential for effective and trustworthy government. At the prior meeting, corrections to the minutes were improperly approved through the consent agenda without discussion. Doing this the right way would have resulted in the same outcome, but would not have created a poor perception. He also objects to the vote on selling the old fire truck because it was raised during board comments instead of being added to the agenda. Although he supports the sale, the process lacked public notice and forced the board members to vote without seeing any information or having time to consider it before the meeting. Although these two things may not have been illegal, they were improper. He would like to know that board members are paying attention to make sure that the board is doing everything the right way.

Planning Commission:

- Meeting November 20, 2025.
 - o Recognized Rich Beukema for his years of service.
 - Public forum was held on the Master Plan and there was input received from the residents and from the township's Planner.
 - Continued working on mining ordinance and reviewed Annual Report.
 Continued discussions on the Capital Improvement Plan.
 - There will be a special meeting tomorrow night at 6:00 PM with the attorney to work on the mining ordinance.

Zoning Board of Appeals:

- Meeting December 9, 2025: They heard an appellant who had purchased an STR with the intent to have the short-term rental continue. It's clearly written that once a property changes hands, STRs are denied so the appeal was turned down on the sale of the property.
- Next meeting will be January 13, 2026 if needed.

Zoning Department:

- VanderKam property: The owner is continuing to work to bring the property into compliance. He has removed debris and a large pile of tires and continues to work on the property.
- There may be a hearing in front of a judge next month.

Fire/EMS Report:

- November 2025 Fire/Emergency Medical responses.
 - o 9 fire alarms during November.
 - Fire Department assisted with the Veterans' Memorial Ceremony.
 - 24 medical responses during November. 5 were during the duty shift and the rest were handled by off duty personnel.
 - Both Fire and Medical responses are slightly below 2024 year to date numbers.
- Chief Miller reviewed the training that was conducted last month.
- The department is working on cost recovery programs, particularly with power line calls, false alarms, etc.
- Discussion is taking place about having the Fire Department take over the snow plowing and mowing for the Fire Station and the Township Hall for possible cost savings to the township.
